Sub: 7<sup>th</sup> CPC Pension Revision -payment for arrears of ICAR-unit-CMFRI Pensioners-reg

Sir,

Please refer to this Institute letter No5-13/75-Audit dated 13.09.2017, authorizing disbursement at revised rate as per VII CPC orders from the month of August,2017 in respect of ICAR unit-CMFRI pensioners/family pensioners who were drawing pension as per VII CPC orders - option-2, by multiplying the existing pension by factor of 2.57.

As indicated in our above mentioned letter dated 13.09.2017, para No. 2, the disbursement of arrears for the period January, 2016 to July, 2017 is hereby authorized.

The enhanced Fixed Medical Allowance of Rs.1000/- w.e.f July, 2017 already authorized, but yet to be paid by disbursing branches in respect of eligible pensioners/family pensioners and already drawing Rs.500, may also be disbursed including arrears for the period July, 2017 to January, 2018.

The CPPC branches concerned may be informed and payment shall be made at the earliest and in any case on or before preferably 28/02/2018 in order to utilize the fund allotted by the Council otherwise fund will be lapsed.

The revision and authorization as per option 1 of O.M No. 38/37/2016-P&PW(A) dated 12<sup>th</sup> May, 2017 is being carried out by the Institute, which may be acted up on as and when Institute revises the pension.

This is issued in conformity with the Council letter No. FIN/10/02/2017-Pension dated 15<sup>th</sup> February, 2018.
