2. Interview of eligible candidates for the above contractual position will be held at the Committee Hall, ICAR-Tuticorin Regional Station of CMFRI, Thoothukudi-1.
3. Only passed-out candidates are eligible to apply. Candidates awaiting the result are not qualified and need not apply.
4. The crucial date for determining the age limit shall be the interview date.
5. For SC/ST candidates, age relaxation of 5 years and three years for OBC candidates will be given as per the Govt. of India/ICAR rules.
6. The above position is purely on a temporary basis. The appointment will be a co-terminus with the termination of the project. Other terms and conditions will be as per the revised ICAR guideline for recruitment of YP in ICAR.
7. The selected candidate will have no right whatsoever for absorption/regularization in the institute.
