- 1. Interview of eligible candidates for the above contractual position will be held at the Committee hall, ICAR-Tuticorin Regional Centre of CMFRI, Thoothukudi-628 001.
- 2. Only passed-out candidates are eligible to apply. Candidates awaiting the result are not qualified and need not apply.

- 3. The crucial date for determining the age limit shall be the interview date.
- 4. For SC/ST candidates, age relaxation of 5 years and three years for OBC candidates will be given as per the Govt. of India/ICAR rules.
- 5. The above position is purely on a temporary basis. The appointment will be a coterminus with the termination of the project. Other terms and conditions will be as per the revised ICAR guideline for recruitment of YP in ICAR.
- 6. The selected candidate will have no right whatsoever for absorption/regularization in the institute.
- 7. The selection of candidates does not entail any right for absorption/ regularization at CMFRI.
- 8. Every candidate has to wear a facemask and follow COVID-19 protocol.
- 9. The service of the selected candidate can be dispensed with even before the termination of the project without any notice if his/her service is no more required or his/her contribution is considered not up to the mark.
- 10. No TA/DA will be paid for attending the interview or to the selected candidate to join the position.
- 11. All eligible candidates are requested to be present 30 minutes before the scheduled time on the interview date to complete the necessary formalities.
- 12. The applicant must bring with them an original document for verification along with one set of complete bio-data in prescribed format with a self-attested photograph and self-attested enclosure such as a mark sheet, proof of date of birth, certificate/degree for qualification, experience and caste certificate for submission in office at the time of interview.
