

In case of more applicants, applications will be screened based on qualifications and/experience and short listed. Shortlisted candidates will be intimated by e-mail, and only those who receive communication may appear for the interview on the specified date and time. Without the production of original caste/ claim certificates, applicants cannot claim any reservation at the time of the interview. Candidates should produce one valid ID proof at the time of the interview. All the original certificates need to be produced at the time of the interview.
