

Walk-in-Interview for the post of Field staff

An Interview is scheduled to be held on 25.04.2025 (10.00 AM) at Vizhinjam Regional Centre of ICAR-Central Marine Fisheries Research Institute, Vizhinjam, Thiruvananthapuram, for the recruitment of a field staff(one no.) under the KSBB funded project "Identification and Removal of Ghost Fishing Nets in the Selected Fishing Zones of Trivandrum Coast for developing strategies for regular monitoring of marine ecosystems" on contract basis. In case of more applicants, applications will be screened based on qualifications and/experience and short listed.
