Notice For Hiring Consultant On Contract Basis For Seaweed Micropropagation, Taxonomy, Farming And Development Of Seaweed Products

ICAR – Central Marine Fisheries Research Institute (CMFRI), Kochi invites applications from the eligible officers with work experience under ICAR/SAU/Research Institutes or retired officers **as consultant for seaweed micropropagation, taxonomy, farming and development of seaweed products (Purely on contract basis)**. The hiring shall be initially for a period of One year, which may be extended or curtailed as per the requirement and satisfactory performance of the consultant.

The details of eligibility criteria (including the remuneration), application form and other terms and conditions of hiring etc. can be downloaded from the CMFRI Website www.cmfri.org.in.

The last date for receipt of applications, in the prescribed format is 30 days from the date of publication of advertisement and can also be sent through e-mail ID director.cmfri@icar.gov.in followed by hard copy within the stipulated time. Applications received after due date/time and without supporting documents will not be considered .

Age Limit : Age should not be more than 65 years on the date of advertisement.

Terms and conditions

- i) Candidates for the post of Consultant with work experience under ICAR/SAU/Institutes or retired Officers of ICAR with pay not less than pay matrix Level – 14.
- ii) Educational qualification – Master’s degree in Botany/Fisheries Science with Doctorate degree in Seaweed Physiology
- iii) Experience required in the relevant field – Retired Officials having 20 years’ of experience in seaweed research, with minimum 5 years’ of experience in Seaweed Tissue culture
- iv) An amount of Rs.60,000/- will be paid as remuneration. The amount of remuneration shall remain unchanged for the terms of the contract.
- v) The consultant shall not be entitled to any allowances such as DA, Transport facility, residential accommodation, CGHS/Medical facility Medical reimbursement etc. However, conveyance allowance shall be paid at the rates as per norms.
- vi) The engagement of consultant will be purely on contract basis and will not confer any right for regular appointment in the Ministry/Organization.
- vii) The retired Government servant engaged as consultant shall continue to draw pension and Dearness Relief on pension during the period of his/her engagement as consultant.
- viii) The engagement as consultant shall not be considered as a case of re-employment.
- ix) The consultant shall be entitled to avail 8 days of leave in a calendar year with imbursement on pro rata basis. Therefore he/she shall not draw any remuneration in case of his/her absence beyond 8 days in a year.
- x) The un-availed leave in a calendar year can neither be carried forward to next calendar year nor be entitled for leave encashment.
- xi) The consultant shall observe the normal office timing and may also be called upon to attend the office on Saturday/Sunday or any holiday in case of exigencies of work.
- xii) He/She shall mark their attendance in the AEBAS mandatorily and failing which may result in deduction of remuneration.
- xiii) The income tax or any other tax will be deducted at source as per Government instructions. Necessary TDS certificate will be issued accordingly.
- xiv) The Intellectual property Rights (IIOR) of the data collected as well as deliverables produced for the Ministry/Organization shall remain with the Ministry.
- xv) No one shall utilize or publish or disclose or part with, to a third party, any part of the data or statistics or proceedings or information collected for the purpose of his/her assignment or during the course of assignment for the Ministry without the express written consent of CMFRI.

 - b) Quality of the assigned work is not to the satisfaction of the controlling Officer/Competent Authority in the Institute.

 - d) The Competent Authority may also terminate the contract at any time without giving any notice and also without assigning any reason.
