INSTRUCTIONS FOR ONLINE BID SUBMISSION

- 1. The tender form/bid downloaded from documents may be the https://eprocure.gov.in/eprocure/app. Online submission of bids through Central Public Procurement Portal (CPP Portal) is mandatory. Manual/offline bids shall not be accepted under any circumstances. Bidders should enrol/register in the e-procurement module of Central Public Procurement Portal through the website www.eprocure.gov.in for participating in the bidding process. Bidders should also possess a valid DSC for online submission of bids
- 2. Tenderers/bidders are requested to visit the website https://eprocure.gov.in/eprocure/app regularly. Any changes/modifications in tender enquiry will be intimated by corrigendum through this website only.
- 3. For Online Bid Submission, as per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. More information useful for submitting the online bids on the CPP Portal is available obtained at "Bidders manual Kit".
- 4. For Registration: Bidders are required to enrol on the e-procurement module of the CPP Portal (<u>URL:http://eprocure.gov.in/eprocure/app</u>) by clicking on the link "<u>Online Bidder Enrolment</u>". Enrolment on the CPP Portal is free of charge.
- 5. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.
- 6. In case, any holiday is declared by the Government on the date of opening, the tenders will be opened on the next working day at the same time. The Director, CMFRI, Kochi reserves the right to accept or reject any or all the tenders.
- 7. Performance Security will be forfeited if the bidder fails to accept the order based on his/her offer (bid) or fail to the work.
- 8. Bidders need not to come at the time of Technical as well as financial bid opening at CMFRI. They can view live bid opening after login on CPP e-procurement portal at their remote end. If bidder wants to join bid opening at CMFRI then they have to come with bid acknowledgement slip that is generated after successfully submission of online bid.
- 9. The firms are also required to upload copies of the following documents:-

Terms & Conditions:

- 1. Tenders received through CPP Portal will only be considered for opening. Bids in any physical form sent through fax/e-mail/courier/post/delivered personally will not be considered.
- 2. The work shall normally be awarded to a single firm whose consolidated bid value is lowest meeting all scopes of work and fulfilling all the term and conditions of the tender. The Director, CMFRI, Kochi-18 reserves the right to accept or reject any or all the quotations either in full or in part without assigning any reason.
- 3. Earnest Money Deposit As per the Ministry of Finance order the bid security is NIL. Then the bidder has to give Bid Securing Declaration as per format Annexure-II.
- 4. The successful bidder shall have to deposit 3% of the total bid amount as performance security and within the time frame indicated at work order.
- 5. Security deposit released after sixty days from the date of completion of the work. Failure to undertake or completion of the awarded work shall make performance security gets forfeited.
- 6. No interest on Security Deposit shall be paid by the CMFRI to the tenderer.
- 7. The rates quoted should be as per our specification.
- 8. Payment will be made after satisfactory completion of work. No advance payment will be made.
- 9. The work should be completed within 30 days from the date of issue of work order.
- 10. Income Tax shall be deducted at source.
- 11. The tenderer is advised to visit the site of work at his own expense and obtain required information for preparing the tender.
- 12. The work shall be carried out strictly according to the direction of the CTO (Civil), E&M Cell, CMFRI, Kochi
- 13.It may be noted that mere quoting the lowest rate will not entitle any firm to get the work order.
- 14. The persons entrusted with the work should carry out the work without causing any damage to the Institute property and disturbance to the staff members. In case of any damage caused, the same will be made good from the payment due to the contractor.
- 15.CMFRI shall have no liability, financial or otherwise, for any harm/damage/injury caused to the manpower/machinery deployed by the firm in the course of performing work of CMFRI.
- 16. The quotation shall be valid for three months from the date of their opening.
- 17. This Office shall not provide any tools and materials required to carry out the work.
- 18. The party should remove the wastes without disturbance to public and take no objection from the local body. Any dispute arising will be settled only on contractors responsibility.



KETCH SHOWING PROPOSED CONSTRUCTION OF LIGHT ROOF


