

- Tender Documents can be downloaded from Central Public Procurement Portal <u>www.eprocure.gov.in</u>. Bidders should enroll/register in the e-procurement module of Central Public Procurement Portal through the website: <u>www.eprocure.gov.in</u>. Bidders should also possess a valid DSC for online submission of bids.
- 2. Bids received on e-tendering portal only will be considered. Bids in any other from sent through sealed cover/email/post/fax etc. will be rejected.
- 3. CMFRI will not be responsible for any delay in enrolment/registration as bidder or submitting/uploading the offer on e-tender portal. Hence, bidders are advised to register in e-tendering website www.eprocure.gov.in and enroll their Digital Signature Certificate and upload their quotation well in advance.
- 4. Any changes/corrigendum/extension of opening date in respect of this tender shall be issued through websites only and no press notification will be issued in this regard. Bidders are therefore requested to regularly visit our website for updates.
- 5. For Online Bid Submission, as per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. More information useful for submitting the online bids on the CPP Portal is available obtained at "Bidders manual Kit".
- 6. For Registration: Bidders are required to enrol on the e-procurement module of the CPP Portal (<u>URL:http://eprocure.gov.in/eprocure/app</u>) by clicking on the link "<u>Online Bidder</u> Enrolment". Enrolment on the CPP Portal is free of charge.
- 7. No extra payment shall be paid on account of any discrepancy in nomenclature of items.
- 8. While submitting the tender, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the tender is liable to be rejected. If any tenderer stipulates any condition of his own, such conditional tender is liable to be rejected.

- 10. Bidders need not to come at the time of Technical as well as financial bid opening at CMFRI. They can view live bid opening after login on CPPP e-procurement portal at their remote end. If bidder wants to join bid opening at CMFRI then they have to come with bid acknowledgement slip that is generated after successfully submission of online bid.
- 11. All the tender documents & Price Bid to be uploaded as per this tender are to be digitally signed by the bidder.

General Terms & Conditions:

- 1. Before quoting for the tender, it is requested to kindly go through the quotation document thoroughly and abide by all the terms and conditions given.
- 2. Before quoting the rates, the site may be inspected.
- 3. Rates quoted must be given in the prescribed format in BOQ only and GST applicable may also be shown.
- 4. Earnest Money Deposit (EMD) The Contractor should furnish an amount of Rs.40,000/-along with the bid in the form of Demand Draft/FDR from any of the Commercial bank in favour of ICAR-CMFRI, Kochi and addressed to the Director, CMFRI, Kochi-18 on or before bid opening date and time as mentioned in the Critical Date Sheet. Name of the tender and tender reference number has to be furnished behind the EMD DD/Bankers cheque. The scanned copy of Earnest Money Deposit by way of Demand Draft/Bankers Cheque in PDF form should be included in Technical Bid of the e-tender. The offers without EMD will be rejected. The EMD will be returned to the unsuccessful bidders after the orders are placed with the successful bidder. Failure to undertake or completion of the awarded work shall make EMD or performance security gets forfeited.
- 5. The quotation must be for the whole work and not in fragments.
- 6. The Institute will not supply any tools, equipment, materials. The contractor has to make their own arrangement.
- 7. Works are to be executed strictly as per the specifications mentioned in the tender document, failing which, payment will not be made. Works may be carried out without causing any damages to Government property. Such damages, if any needs to be compensated by the Contractor.
- 8. Mandatory tax will be deducted at source from the bill as per rules.
- 9. GST registered Agencies/Firms should quote the GST rate mandatorily.
- 10. 1% of the billed amount towards water charges will be recovered, if water for the work is supplied by the Department.
- 11. Deductions for electrical charges either on actual basis or at the rate of 1% of the billed amount will be made if the electricity is supplied by the Department.

- 12. The successful bidder shall have to deposit 5% of the total bid amount as performance security and within seven days of the award of the work. This amount shall be refundable without any interest after 60 days from the date of completion.
- 13. Payment will be made after satisfactory completion of work. No part payment advance payment will be made.
- 14. The agency has to abide by all rules and regulations pertaining to labour act. The contractor has to take all necessary steps for the welfare measures of labour employed by him at the site.
- 15. The agency will be fully responsible for providing medical facilities to their labourers in case of any accident etc. Matters related to labour welfare/problems should be dealt by the contractor only. CMFRI, Kochi shall not be responsible in such matters.
- 16. The tenders/bidders in their own interest are instructed to visit the site for understanding the site conditions, nature of work involved etc.
- 17. Legal jurisdiction for all disputes shall be within the purview of Ernakulam.
- 18. The work should be completed within 54 days from the 7th day of award of work. If it is not completed in the scheduled time a penalty @ 0.25% from the total cost of work shall be imposed at the first week. Further delay will attract increase in the penalty up to a maximum of 2% for every week.
- 19. No labour of the contractor will be allowed to stay within the campus/site of the work.
- 20. Dismantled items or any debris are to be removed from the site at your cost.
- 21. The work shall be carried out strictly according to the direction of the CTO (Civil), E&M Cell, CMFRI, Kochi
- 22. The decision of the Competent Authority shall be the final to select the competent firms/contractors.
- 23. The quotation shall be valid for six months from the date of their opening.


